### **President's Report**

Jared Davidson presented his annual report. He thanked his Council members for their efforts in what had been a difficult year to navigate but one of progress towards a more resilient organisation. He thanked Scott Lanauze for his willingness to return to assist the Council with supporting the administration of the organisation.

### **Proposed Rule Changes**

The following rule changes were presented to the meeting

#### • Amendment to Rule 3.7.1:

**Current Rule:** Shall be any person who is elected Life Honorary Member on the nomination of the Council, by the unanimous vote of members at the annual meeting of the Institute

**New Rule to read:** Shall be any person who is elected Life Honorary Member on the nomination of the Council, by *an affirmative vote of at least 80% of the* members at the annual meeting of the Institute.

**Reason for Rule Change:** This voting percentage is consistent with that of the new rules of the UFBA in how the UFBA Life Honorary Member is selected. This change ensures consistency with both organisations.

#### Amendment to Rule 6.1 (and associated change to Rule 6 to read Secretary / Treasurer):

**Current Rule:** The Secretary of the Institute shall be the Chief Executive Officer of the UFBA as defined by Rule 15.3 of the Constitution of the UFBA.

**New Rule to read:** The Council shall appoint a Secretary and/or Treasurer of the Institute. The Council shall, as and when necessary, seek suitable applicants to be nominated from within its membership for either or both positions should a vacancy occur. The Council may fill either or both positions by election if required.

Reason for Rule Change: Rule 15.3 no longer exists in the new UFBA constitution. Consequently, the CEO of the UFBA is now no longer constitutionally bound to be the Secretary of the NZFBI. This rule change ensures the NZFBI is able to maintain a Secretarial position. Additionally, it also allows the individual to manage the finances on behalf of the NZFBI Council. Allowing for the positions to be held by one or two individuals allows flexibility should individuals with specialised qualifications express a desire to manage one of the portfolios. It would also lesson the burden of both roles that one person will manage.

#### New Rule 6.2:

**New Rule to read:** The Secretary / Treasurer shall give at least three months' notice of resignation from the position to enable selection of a replacement. Likewise, the Council will provide at least three months' notice to the Secretary / Treasurer if the services of the individual fulfilling the role is no longer required.

**Reason for Rule Change:** This rule allows transparency for both parties should the need for the position to be vacated arises.

The previous Rule 6.2 will become Rule 6.3.

New Rule 6.3.6:

New Rule to read: Maintain the operating finances for the Council.

**Reason for Rule Change:** This highlights that this position will manage the daily running of the finances for the Council.

Amendment to Rule 8.1:

Current Rule: Shall be held annually and in conjunction with the UFBA Annual Conference.

**New Rule to read:** Shall be held annually *and, where possible,* in conjunction with the UFBA Annual Conference.

**Reason for Rule Change:** This allows flexibility for the NZFBI that, should a situation arise where the NZFBI are unable to run their AGM in conjunction with the UFBA, they still have the ability to do so independently.

Past President Peter Moore sought clarification from the meeting as to how Rule 8.2 had been satisfied as the details of the proposed rule changes had not been provided within the two-month timeframe. Following a brief discussion, it was agreed to put a motion to the meeting to allow the rule changes to proceed.

MOTION: That the proposed rule changes are put to the AGM today.

# **Regulation Changes**

Jared Davidson introduced changes to two regulations.

<u>Awarding of Diplomas Regulations – Sections 3.1 and 3.2</u>

#### 3. Awarding of Diplomas

- 3.1. Associate Diploma (AMNZFBI)
  - 3.1.1. An Associate Diploma shall be awarded to a candidate through one of the following means:
    - 3.1.1.1. Completion of two (2) two-hour NZFBI Associate Member examinations with a minimum average grade of sixty (60) percent across both examinations.
    - 3.1.1.2. Completion of the Institution of Fire Engineers Level 2 Certificate in Fire Science, Operations and Safety.
- 3.2. Member Diploma (MNZFBI)
  - 3.2.1. A Member Diploma shall be awarded to a candidate through one of the following means:

- 3.2.1.1. Completion of two (2) three-hour NZFBI Member examinations with a minimum average grade of sixty (60) percent across both examinations.
- 3.2.1.2. Completion of the Institution of Fire Engineers Level 3 Certificate in Fire Science, Operations, Fire Safety and Management.

# Subscriptions and Fees Regulations – Sections 3 and 4

# 3. Subscriptions

- 3.1. Affiliated Members
  - 3.1.1.The annual subscription for affiliate membership of the Institute shall be set from time to time by the Council.
- 3.2. Financial Members
  - 3.2.1. The annual subscription for financial membership of the Institute shall be set at \$30.00.
  - 3.2.2. Annual membership subscriptions shall fall due on 1 July each year.

#### 4. Fees

- 4.1. NZFBI Associate Examination Fee
  - 4.1.1. (Reserved)
- 4.2. NZFBI Member Examination Fee
  - 4.2.1. (Reserved)
- 4.3. NZFBI Fellow Diploma Application Fee
  - 4.3.1. The fee for applying for the NZFBI Fellow Diploma shall be set at \$100.00. This fee is non-refundable.
- 4.4. Institution of Fire Engineers (IFE) Examinations Fees
  - 4.4.1. The fee for sitting the IFE examinations is not set by the Council, however the fee for each examination will be released by the NZ Branch of the IFE annually and will be made known to the candidate as part of the application.

Jared Davidson advised that the membership subscription was to remain the same for the coming year.

## **General Business**
